School Annual Education Report (AER) Cover Letter

Dear Parents and Community Members:

We are pleased to present you with the Annual Education Report (AER), which provides key information on the 2020-21educational progress for Spring Lake High School. The AER addresses the complex reporting information required by federal and state laws. The school's report contains information about student assessment, accountability, and teacher quality. If you have any questions about the AER, please contact Ben Armey for assistance.

The AER is available for you to review electronically by visiting this link, or you may review a copy in the main office at your child's school.

For the 2020-21 school year, schools were identified based on previous years' performance using definitions and labels as required in the Every Student Succeeds Act (ESSA). A Targeted Support and Improvement (TSI) school is one that had at least one underperforming student subgroup in 2018-19. An Additional Targeted Support (ATS) school is one that had a student subgroup performing at the same level as the lowest 5% of all schools in the state in 2017-18. A Comprehensive Support and Improvement (CSI) school is one whose performance was in the lowest 5% of all schools in the state or had a graduation rate at or below 67% in 2016-17. Some schools are not identified with any of these labels. In these cases, no label is given.

Our school was identified as a: Spring Lake High School 'HAS NOT BEEN GIVEN ONE OF THESE LABELS."

Key challenges for SLHS in reviewing data includes the continued impact of COVID 19 on assessment participation (mainly due to absences related to positive COVID cases or quarantined students. Despite these challenges, Spring Lake High School staff consistently review data, discuss ways to improve instruction, and program based on gap areas for students at all three tiers of performance (tiers 1-3).

State law requires that we also report additional information including the following:

- 1. Pupils are assigned to this school based on their geographic residence within the district boundaries, or through the Schools of Choice process.
- 2. SLHS continues to work towards goals of the School Improvement Plan.
- 3. There are no specialized schools within SLHS.
- 4. The core curriculum can be accessed through the SLHS website. The core curriculum is implemented by staff each year, who follow a seven-year review cycle as a means to continuously update curriculum. SLHS follows all state guidelines in implementing required curriculum.

- 6. Approximately 410 students were represented at Parent Teacher Conferences this year (by parents). That number equates to approximately 48 percent of the student body.
- 7. Other required information:
 - a. SLHS had 141 Dual Enrollment/Early College students representing approximately 8 percent of all students.
 - b. SLHS offered 20 AP and IB courses during the 2020-21 school year.
 - c. 435 student seats were filled in AP and IB courses, representing just over 50 percent of the student population.
 - d. 121 of 149 (81%) student tests earned scores on the AP Exam that could qualify them for college credit (3,4,5). 68 of 75 (90%) student tests earned scores on the IB test that could qualify them for college credit.

We are proud of the work our students have done to push through adversity during the 2020-21 school year. Stakeholders have rallied together to keep academic progress as the primary focus for our students and all Lakers should be proud of our continued achievement in the classroom and through extracurricular activities.
